The property offers in-place income with significant long-term upside through redevelopment and assemblage potential, along with flexibility for a future parcel split, within one of Metro Detroit's most desirable suburban downtown districts.

Located just west of downtown Farmington along Grand River Avenue, the property consists of a 1,769 square foot, two-story single-family rental home at 33614 Grand River Ave and a 1,183 square foot, single-story duplex situated directly behind at 33615/17 Adams Street.

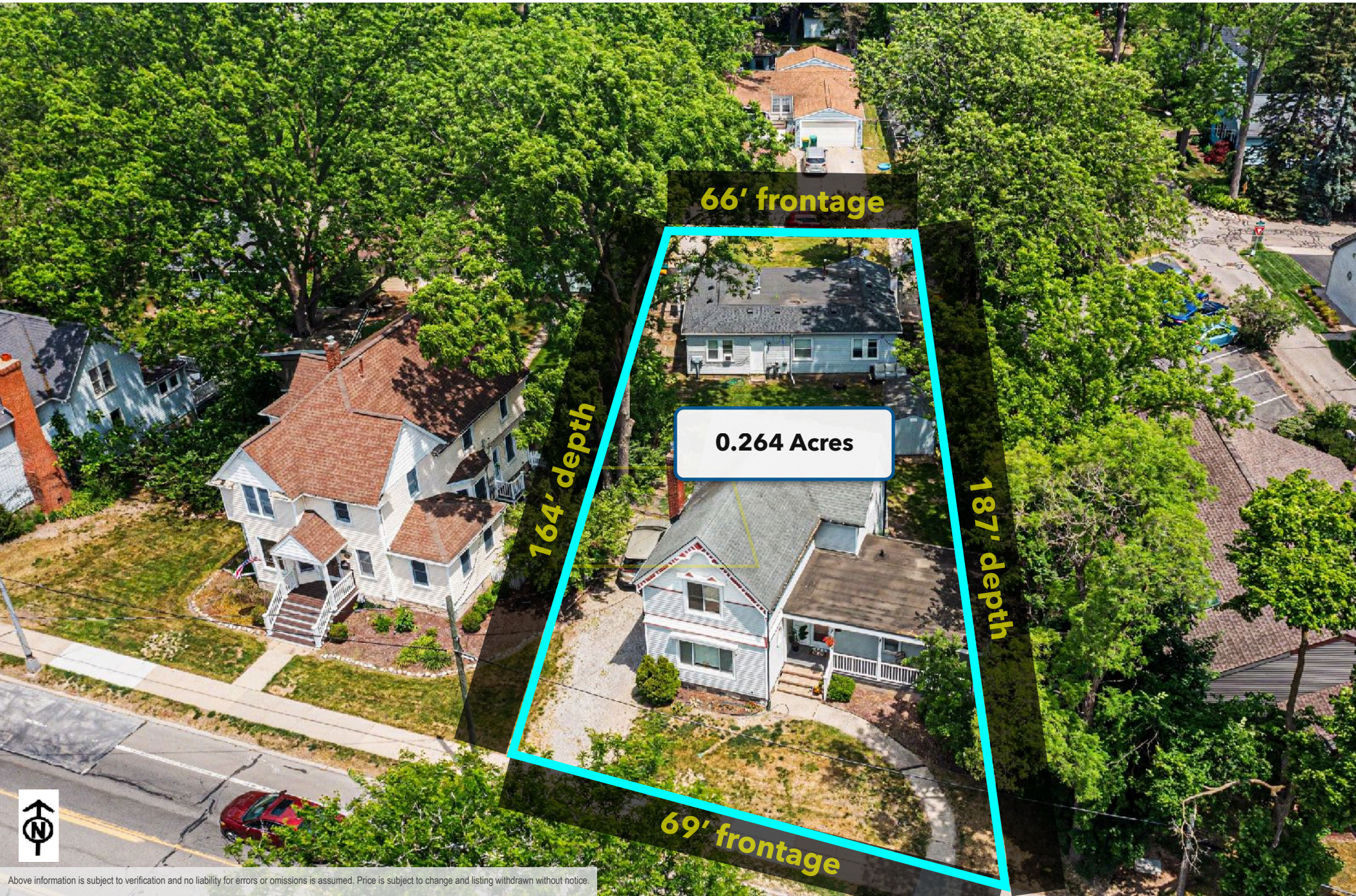

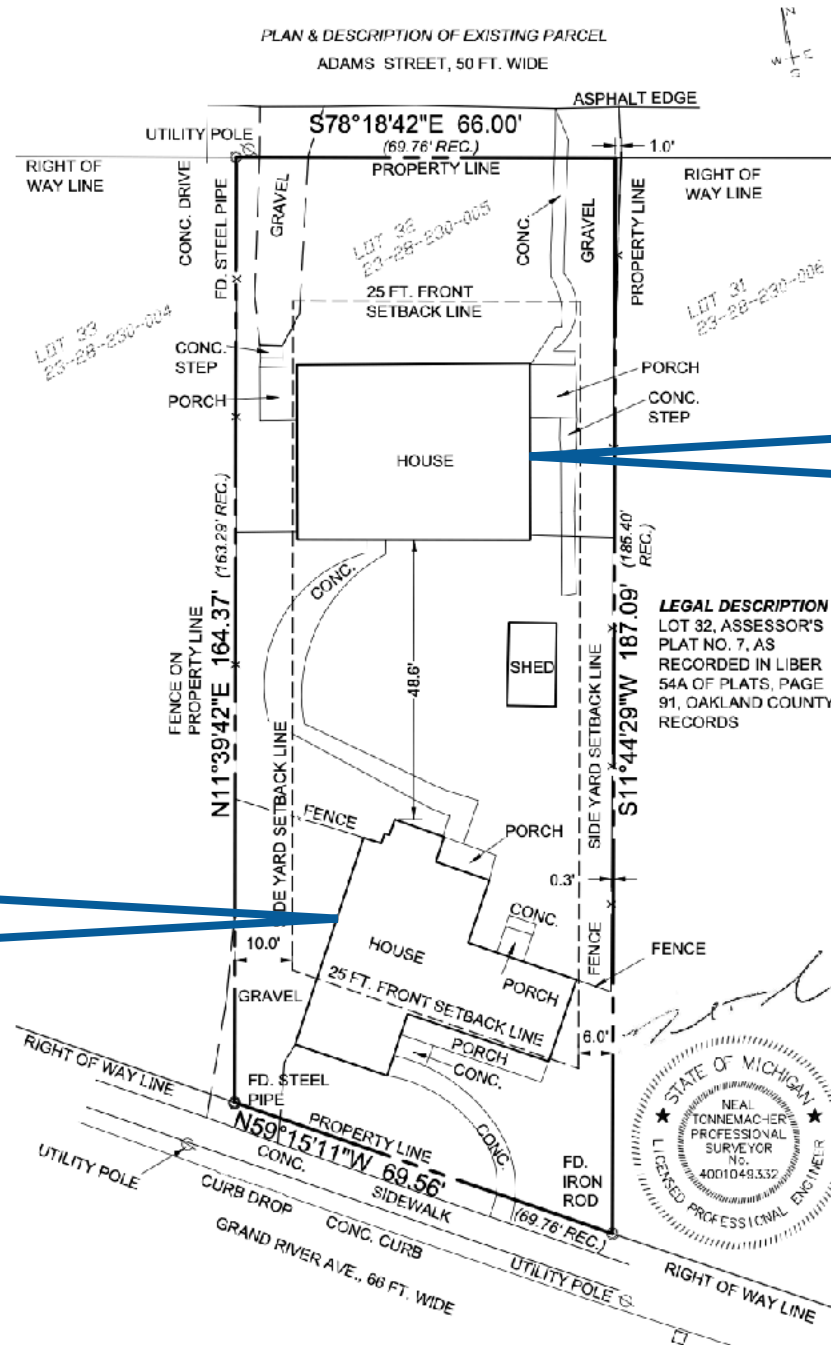

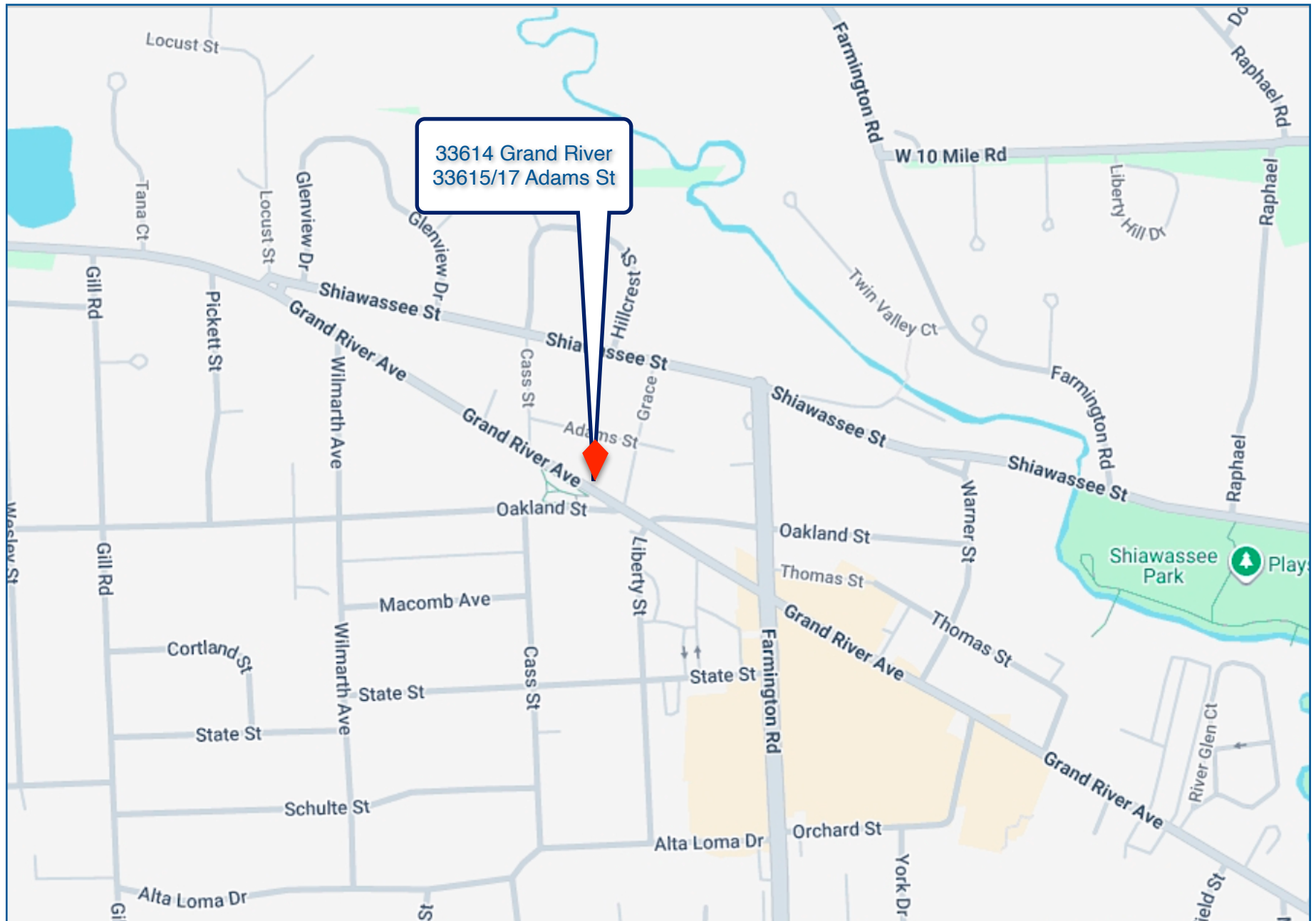
